4. **No Ownership Connection** - There shall be no other ownership connection between the business operating under the trade name now owned by Licensor and the future business operating under the trade name to be owned by Licensee or any other business owned by Licensee under any trade name. Licensee shall hold Licensor harmless and shall indemnify Licensor for all costs, assessments, judgments and costs and legal expenses - including attorney's fees - that Licensor shall incur by reason of or as a result of Licensee's operation of Licensee's business(s).

Licensee shall hold Licensor harmless and shall indemnify Licensor for all costs, assessments, judgments and costs and legal expenses - including attorney's fees - that Licensor shall incur by reason of or as a result of Licensee's operation of Licensee's business(es).
5. No Limitation on Licensee's other Businesses - This agreement shall not prohibit or limit Licensee from opening other similar businesses in any region provided that the name "Zig Zag Bail Bonds" or any confusingly similar name is not used for such business.
6. Consideration - In consideration for the above license, Licensee agrees to pay Licensor the amount of \$3,500.00 per month for 86 months and Lynn Simon releases her full interest in the property located at 5665 Uplands Dr., Tahoe. The Licensee shall pay Licensor said amount starting November 1<sup>st</sup> 2003 and every month thereafter for a total of 86 months.
7. Termination of Contract - In the event that bail industry in California is shut down and no longer exist then the payments will cease. Tahoe has no relationship to the termination of said monthly payments. Tahoe remains as stated in item #6.


