**DECLARATION FOR CORRECTION OF OWNERSHIP
TRADEMARK REGISTRATION 3,153,660
Serial No. 78/727,989**

I, Paul Fariello, declare as follows:


1. I am a U.S. citizen residing in Blue Bell, Pennsylvania. My post office address is 903 Valley Road, Blue Bell, PA 19422.
2. I am a principal of the joint venture Paul Hammond, Owner of record of Trademark Registration 3,153,660, Application Serial No. 77/581,833, GET THE LED OUT for "Entertainment in the nature of visual and audio performances, namely, musical band, rock group," in Class 41.
3. At the time the Application was filed, on October 6, 2005, our musical band and joint venture consisted of myself (Paul Fariello), Paul Hammond (an individual), Paul Piccari and Adam Ferraioli.
4. Over the course of the next few years, my joint venture partners and I determined that Paul Piccari was no longer a productive or reliable member of our musical band. Consequently, in or around 2/04/10 [date] we held a band meeting and resolved to oust Piccari from the musical band and the joint venture.
5. On or around 2/21/10 [date] we informed Piccari that we had ousted him from the musical band and joint venture known as GET THE LED OUT.
6. We informed Piccari that his interest in the joint venture was terminated effective immediately and we paid him \$3,016.94 in exchange for leaving the joint venture and musical band and releasing all interest in the joint venture and musical band and its assets.
7. Since 2/22/10 the remaining three joint venture partners (myself, Hammond and Ferraioli) have continued to perform entertainment services as the musical band GET THE LED OUT. Piccari has not.
8. It was my intent, and the expressed intent of Hammond and Ferraioli, that when he was ousted from the musical band and joint venture, Piccari's 1/4 interest in the joint venture and all its assets reverted back to the joint venture and were merged equally with the remaining three interests, increasing the interest of each of us (Hammond, Ferraioli and myself) from 1/4 to 1/3. We have continued to conduct the affairs of the joint venture as such. Piccari has made no claim of interest or ownership.
9. We now seek to correct the Registration to reflect the current composition and address of our joint venture, as follows:
Paul Hammond, a joint venture organized under the laws of PA, comprising Paul Fariello (USA), Paul Hammond

(USA) and Adam Ferraioli (USA), having an address of 903 Valley Road, Blue Bell, PA 19422.

10. I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the Trademark Registration.
