TRADEMARK ASSIGNMENT

WHEREAS Thane International, Inc. ("Thane"), a Delaware corporation, located at 78-140 Calle Tampico, Suite 201, La Quinta, California 92253 (hereinafter "Assignor") and RKS Design International, Inc., a California corporation (hereinafter "Assignee"), (together, the "Parties") entered into a Production and Exclusive Marketing Agreement ("Agreement") on or about March 5, 2002, pursuant to which the Parties agreed that Assignor would file "for a trademark for the name 'Q'" on Assignee's behalf and would be the trademark licensee of Assignee;

WHEREAS the counsel who was hired to file for the trademark for the "Q" mark, who was then counsel to both Parties, determined that the Parties could not trademark a letter in the English alphabet such as "Q" and, for that reason, did not file for such a trademark;

WHEREAS Assignor, at its sole expense, instead then filed for an application for registration of a trademark for the stylized depiction of the letter "Q" and did so in its own name for that stylized mark;

WHEREAS, Assignor has adopted, used, and registered the stylized mark depicting the letter "Q" (the "Trademark") in the United States Patent and Trademark Office as follows:

WHEREAS, Assignor and Assignee agree that the Trademark was used with and applied to the portable barbeque "Q" grill that was marketed by Assignor and was produced under a patent license from Assignee;

WHEREAS, the Parties agree that Assignor at all times was licensed to use the Trademark, as applied to Assignee's patented "Q" grill and related accessories that were associated with Assignee's patented product, and that Assignor's use of the Trademark was never an infringing use of the Trademark;

WHEREAS, the Parties now agree that Assignor had a contractual obligation to assign the Trademark to RKS as of March 5, 2002;

WHEREAS, the parties now agree that the assignment dated October 14, 2009 signed by Mark Taylor and filed with the United States Patent and Trademark Office on November 5, 2009 (reel/frame No. 004091/0757) contained an error in the effective date of the assignment, as such the Parties further agree that the assignment dated October 14, 2009 is null and void in favor of the present assignment.

NOW, THEREFORE, Assignor does hereby assign unto the said Assignee all right, title and interest in and to the Trademark, as shown by United States Patent and Trademark Office registration number 2,787,586, having a first use in commerce of July 11, 2003, together with the goodwill of the business symbolized by the Trademark, *nunc pro tunc*, as of November 26, 2003 from Assignor to Assignee consistent with the Production and Exclusive Marketing Agreement dated March 05, 2002 and as amended on October 27, 2003 and again on July 21, 2004 and the settlement agreement dated October 15, 2009. Further, the Assignor does hereby assign unto the said Assignee all right, title and interest in and to the registration for the Trademark,

United States Patent and Trademark Office registration number 2,787,586, *nunc pro tunc*, as of November 26, 2003.
