TRADEMARK CLAIM ASSIGNMENT AGREEMENT

WHEREAS, the Parties desire that Assignce pursue the infringement claims in the Lawsuit on behalf of the Assignors and Assignce.

NOW THEREFORE, the Parties agree as follows:

- 1. <u>Assignment.</u> For \$10.00 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby irrevocably convey, transfer, and assign to Assignee all of Assignors' right, title, and interest in and to the trademark infringement claims against DRE Health Corp and all DRE Health Corp's resellers and distributors as more fully set forth in the Lawsuit ("Claims").
- 2. <u>Control of Lawsuit</u>. Assignee shall have full control of the Lawsuit including hiring and directing counsel, settlement, trial or other resolution of the Lawsuit. Assignee shall be responsible for the payment of all costs and fees associated with the Lawsuit and any other assertion of the Claims.
- 3. <u>Counterparts</u>. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
- 4. <u>Successors and Assigns</u>. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
- 5. Governing Law. This Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Georgia, without giving effect to any choice or conflict of law provision or rule (whether of the State of Georgia or any other jurisdiction).
